 - e. The publication officer, Jenny Butler reports on publication issues.
 - a. Satoko Fujiwara reports on <u>IAHR</u> activities and that the plans for the 2025 congress are progressing. See IAHR bulletin for further information on these activities.
- 9. The nominating committee for the 2025 election of new officers is presented and approved. It consists of James Kapalo, Karna Kjeldsen, Mar Marcos, Katja Triplett and David Zbiral
- 10. The president presents an addition to the Codes of Conducts for conferences: "Conference participants are reminded that during the period of the conference, they are guests in the host country, and should conform to the Code of Conduct both in and beyond the conference venue". The addition is approved by the GA. The president also reminds of the codes of conducts for email-lists.
- 11. Future Conferences:
 - The 2025: IAHR Congress in Krakow, Poland is presented.
 - The General Secretary reminds about the 2026: Romanian Association, Bucharest, with the tentative dates 20-25th of September.
- 12. A New Membership Application from the Slovenian Association is presented. It is approved by the general assembly.
- 13. Karna Kjeldsen from The EASR working group on Religion in Secular Education presents a revised statement on 'Religion in Public Education'. It is approved by the GA.
